# Three types of arguments have been usually put forward

**First :** print popularised the ideas of the Enlightenment thinkers.

Collectively, their writings provided a

- critical commentary on tradition, superstition and despotism.
- They argued for the rule of reason rather than custom, and demanded that everything be judged through the application of reason and rationality.
- They attacked the sacred authority of the Church and the despotic power of the state, thus eroding the legitimacy of a social order based on tradition.

**Second :** Print created a new culture of dialogue and debate.

- All values, norms and institutions were re-evaluated and discussed by a public that had become aware of the power of reason, and recognised the need to question existing ideas and beliefs.
  - **Third**: By the 1780s there was an outpouring of literature that mocked the royalty and criticised their morality. In the process, it raised questions about the existing social order.
- Cartoons and caricatures typically suggested that the monarchy remained absorbed only in sensual pleasures while the common people suffered immense hardships.
- 7. (A) 1. The Khilafat movement began after World War.
  - 2. Gandhiji recognized this issue as a chance to unite Hindus and Muslim.
  - 3. He believed that supporting the Khilafat would unite Hindus and Muslims.

- (B) First, the war created a new economic and political situation.
- It led to a huge increase in defence expenditure which was financed by war loans and increasing taxes: customs



- duties were raised and income tax introduced.
- Through the war years prices increased doubling between 1913 and 1918 leading to extreme hardship for the common people.
- Villages were called upon to supply soldiers, and the forced recruitment in rural areas caused widespread anger.
- Then in 1918-19 and 1920-21, crops failed in many parts of India, resulting in acute shortages of food. This was accompanied by an influenza epidemic. According to the census of 1921, 12 to 13 million people perished as a result of famines and the epidemic.

- (ii) The inhabitants of five villages in the Alwar district of Rajasthan have declared 1,200 hectares of forest as the Bhairodev Dakav 'Sonchuri', declaring their own set of rules and regulations which do not allow hunting, and are protecting the wildlife against any outside encroachments.
- The famous Chipko movement in the (iii) Himalayas has not only successfully resisted deforestation in several areas but also shown that community has afforestation with indigenous species can be enormously successful. Farmers and citizen's groups like the Beej Bachao Andolan in Tehri and Navdanya have shown that adequate levels of diversified crop production without the use of synthetic chemicals are possible and economically viable.

- 26. All this changed significantly after 1990. This period saw the rise of regional political parties in many states of a country.
- This was the beginning of the new era of coalition government.
- Since no single party gets a clear majority in the Lok Sabha, the major national parties had to enter into an alliance with many parties including several regional parties to form a government at the Centre.
- This led to a new culture of power sharing and respect for the autonomy of State Governments.
- This trend was supported by a major judgement of the Supreme Court that made it difficult for the Central Government to dismiss state governments in an arbitrary manner.
- 27. (A) (i) When an elected MP or MLA changes his party it is called Defection.
- The constitution was amended to prevent elected MLAs and MPs from changing parties.
- This was done because many elected representatives were indulging in defection in order to become ministers or for cash rewards.
- Now the law says that if any MLA or MP changes parties, he or she will lose the seat in the legislature.
- This new law has helped bring defection down.
- (ii) The Supreme Court passed an order to reduce the influence of money and criminals.
- Now it is mandatory for every candidate

- who contests elections to file an Affidavit giving details of his property and criminal cases pending against him.
- (iii) The Election Commission passed an order making it necessary for political parties to hold their organisational elections and file their income tax returns. The parties have started doing so but sometimes it is mere formality.

- (B) (a) Contest elections: Parties contest elections. In most democracies, elections are contested mainly among the candidates put up by political parties. Parties select their candidates in different ways.
- (b) Declaration of Policies and Programmes:
  There are always some socio-economic and political issues before the nation at the domestic and international levels.
  Political parties put forward their considered views and policies before the people and suggest ways to tackle the issues.
- (c) Making laws: Parties play a decisive role in making laws for a country. Formally, laws are debated and passed in the legislature. But since most of the members belong to a party, they go by the direction of the party leadership, irrespective of their personal opinions.
- (d) To form and run the Government:
  Formation of government is one of the aims and functions of a political party.
  The big policy decisions are taken by political executive that comes from the political parties. Parties recruit leaders, train them and then make them ministers to run the government in the way they want.
- (e) Role of opposition: Those parties that lose in the elections play the role of opposition to the parties in power, by voicing different views and criticising government for its failures or wrong policies. Opposition parties also mobilise opposition to the government.
- (f) Shape Public Opinion: Parties shape public opinion. They raise and highlight issues. Parties have lakhs of members and activists spread all over the country. Many of the pressure groups are the



- extensions of political parties among different sections of society.
- (g) Access to Government machinery and welfare schemes: Parties provide the people an access to the government machinery and welfare schemes implemented by governments. For an ordinary citizen it is easy to approach a local party leader than a government officer. That is why they feel close to parties even when they do not fully trust them.
