New Delhi, December 20th: The NGO, the Women Empowerment Organisation (WEO) in association with Child and Women Care Society (CWCS) observed the women empowerment day at community centre Block ,B -Rohini today. The main purpose was to create awareness of Women's right and to empower women. As many as 50 members of the self-help groups formed by WEO and CWCS in the area participated in the programme. The programme began with a welcome dance by the renowned dancer Mala Dey and followed by a talk by WEO members.

Mrs Aradhana Saxena, District Magistrate Rohini stressed upon the importance of education for girls. She also gave details about 'Sarv Shiksha Abhiyan' an initiative by the government under which students are given books free of cost. - VII. (i) The Lesson 'Lost Spring' describes the pathetic condition of the bangle makers. On the one hand it is the plight of the street children forced into labour early in life and denied the opportunity of studying in schools. The glass industry has its own hazards. The illegal employment of very young children and the pathetic working conditions lead to many children becoming blind. They work in glass furnaces with high temperatures. Their dingy cells have no light, no ventilation. Boys and girls work under these conditions while welding pieces of coloured glasses to make bangles. Their eyes are more adjusted to the dark than to the light outside. They thus often lose their eyesight at a very young age. Over and above this, it is the apathy and callousness of society and the political class to the sufferings of the poor that makes us feel sympathetic towards these bangle makers. The poverty stricken bangle makers also suffer because of the exploitation at the hands of the middlemen and politicians. They did not improve their lot and instead get only beaten up by the police. They are unable to organise themselves. So, their life is full of suffering that is physical and emotional.

In the poem 'Roadside Stand' Robert Frost presents the lives of the disadvantaged poor and (ii) in the process shows the rich urban as being indifferent. The poor lead a pathetic life, beg for financial assistance by selling some home made products in order to sustain themselves. On the other side, the rich move in sophisticated vehicles insensitive to the plight of the poor that begs for attention. These absorbed city dwellers have the money but do not want to spend it on poor country side people. Frost points out that city people just do not pay attention to these poor people. They say nothing but their ugly facial expressions and even their silence speaks a lot about their apathy and indifference towards rural people. Moreover, city dwellers want to take away the rural people's source of livelihood but pretend to be helpful. Men in power enforce such benefits on country folk which in reality are meant for their own benefit. Like flies these so-called rich city dwellers swarm over the lives of rural folk to cheat them for their selfish gains. The poet Robert Frost sympathises with these rural folks and would like to do something to relieve these poor people of misery and poverty.

The Tiger King spent most of his time in killing the innocent animals just to disprove the prediction of an astrologer. He was selfish, self-centred and cruel. He ignored all the duties of a ruler. He did not do anything for the welfare of his state. He could even bribe the British officers to save his Kingdom and to appease them. He was a vain and obstinate ruler whose only purpose of life revolved around his own conceit and power. The Tiger King does not deserve to be called Maharaja because he doubled the taxes for no fault of the villagers rather because things didn't work as per his wishes. He misused his power and authority to serve his own personal motives. His dewan and minions obeyed him out of fear, not respect. His attitude towards his people was no different from his attitude toward the tiger. The Tiger King married because he wanted to complete his target of killing hundred tigers. The gift that he bought for his son on his birthday did not have any emotional appeal. His obsession for tigers did satisfy even after the killing of the hundredth tiger.

India and Antarctica were parts of the same land mass. Then the supercontinent disintegrated into many parts. It is a place where ninety percent of the Earth's total ice volumes are stored. We lose all earthly sense of perspective and time here. There are no billboards and buildings. We can see from midges and mites to blue whales and icebergs. Antarctica is the perfect place to study how little change in the environment can have big repercussions. It is the only place in the world which has never sustained a human population. It remains relatively pristine in this respect. It has a very simple ecosystem. It lacks biodiversity. Scientists warn that a further depletion in the ozone layer will affect the food chain. It will also affect the lives of all marine animals and birds of the region. Similarly, if global warming makes Antarctica a little warmer than it will have disasterous consequences.
